



Protection Of Personal Data Information Notice For Security Cameras

In accordance with Law No. 6698 on the Protection of Personal Data ("Law"), **ÖZ İNŞAAT TUR.PET. GIDA SAN.VE TİC.LTD. ŞTİ.** (hereinafter referred to as "**SİDE PREMIUM**") is designated as the data controller due to its processing of your personal data. Under Article 10 of the Law, titled "Obligation to Inform," data controllers are required to provide certain information to individuals whose personal data they process.

This notice has been prepared by **SİDE PREMIUM** to ensure compliance with the legislation and to maintain transparency and accountability.

Definitions

According to Law No. 6698 on the Protection of Personal Data:

Personal Data refers to any information related to an identified or identifiable natural person.

Processing of Personal Data means any operation performed on personal data, whether wholly or partially automated or conducted by non-automated means, provided that it is part of a data recording system. This includes collection, recording, storage, retention, alteration, reorganization, disclosure, transfer, acquisition, making available, classification, or prevention of use.

Data Subject refers to the natural person whose personal data is processed.

Data Controller refers to the natural or legal person who determines the purposes and means of processing personal data and is responsible for establishing and managing the data recording system.

Obligation to Inform refers to the responsibility of the data controller or its authorized representative to inform data subjects at the time of collecting personal data about the identity of the data controller, the purpose of data processing, the parties to whom the processed personal data may be transferred and the purpose of such transfer, the method and legal basis for data collection, and the data subject's rights as stated in Article 11 of the Law.

Data Subject : As individuals whose personal data is processed through security cameras installed in our service areas, you are defined as data subjects under the Law.

Data Controller : SİDE PREMIUM is the data controller responsible for determining the purposes and means of processing your personal data, as well as for establishing and managing the data recording system.

The service building is equipped with 200 security cameras located at various points including the entrance doors, building façade, dining hall, cafeteria, visitor waiting room, parking lot, security booth, and floor corridors. These cameras record video footage for the purpose of ensuring the security of the building. The recording process is monitored by the security department.

Personal Data Processed According to the Processes, Purposes of Processing, and Legal Grounds

- **Physical Space Security (*Camera Recording*) Data**

- For the purpose of ensuring physical space security and conducting storage and archiving activities (obtaining and storing security camera recordings).
 - **Article 5/2(f) of the KVKK:** Processing of personal data is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject (*The collection and storage of camera recordings for physical space security purposes serves our legitimate interest as the data controller*).

Recipients and Purposes of Personal Data Transfers

Your personal data may be transferred to the relevant authorities upon request without the obligation to inform you and without requiring your explicit consent, in accordance with Article 28/1 of the Personal Data Protection Law (KVKK).

In addition, in unforeseen circumstances, your personal data may also be transferred to public institutions explicitly designated by law (such as ministries and other administrative authorities), provided that such transfer is conducted within the legal purposes and limitations prescribed by the law.

Apart from legal obligations that do not require an obligation to inform or your explicit consent, your personal data will not be transferred.

Methods of Obtaining Personal Data

Your personal data is obtained through **automated means** via **security cameras** as you enter the premises, within the camera's viewing area.

Your Rights Regarding Your Personal Data

Data subjects are required to submit their rights regarding their personal data primarily to the data controller.

Under the Law, regarding your personal data, you have the right to:

- a) Learn whether your personal data is being processed,
- b) If your personal data has been processed, request information about it,
- c) Learn the purpose of processing your personal data and whether it is used in accordance with the intended purpose,
- ç) Learn the third parties to whom your personal data has been transferred, both domestically and internationally,
- d) Request the correction of your personal data if it is incomplete or incorrect,
- e) Request the deletion or destruction of your personal data when the reasons for processing no longer exist,
- f) Request that any actions taken under (d) and (e) be notified to the third parties to whom your personal data has been transferred,
- g) Object to any decision made solely based on the automated processing of your personal data that produces legal consequences for you,

ğ) In the case of damage caused by the unlawful processing of your personal data, request compensation for the damage.

Method of Application to the Data Controller

You can submit your application by:

Your application must include:

- Your full name, surname, and signature if the application is written,
- For Turkish citizens, your Turkish Republic ID number; for foreigners, your nationality, passport number, or, if available, identity number,
- Your residence or workplace address for notification purposes,
- If applicable, your email address, phone, and fax number for notifications,
- The subject of your request.

In addition, if relevant, any information and documents related to the subject should be included with your application.

SİDE PREMIUM reserves the right to verify your identity.
